# Fully Automated Pretrial and Probation Monitoring for Low-Risk Offenders

Increase the Productivity and Effectiveness of Your Probation Officers



Many probation officers (POs) are having difficulty managing the large number of probation clients assigned to them, and client-to-PO ratios of 100:1 and 125:1 are not uncommon. This situation strains state probation systems, and can lead to decreased public safety and increased offender recidivism.

The AB Kiosk™ increases the effectiveness of probation officers by fully automating all pretrial and probation check-ins for low-risk offenders. In effect, the AB Kiosk creates a full probation-monitoring system that both streamlines and strengthens check-ins for low-risk offenders while forging closer supervision of high-risk offenders. Perhaps most importantly, it enables POs to separate low- and high-risk offenders throughout the probation process, thereby reducing the likelihood that low-risk offenders will be negatively influenced by high-risk offenders. The Kiosk can be located in the lobby outside the secure area of a jail or courthouse, eliminating the need for staff to clear dozens of people a day.

AB Kiosks measurably increase the productivity and effectiveness of probation officers in several ways:

- Separates low-risk probationers from high-risk probationers
- Presents offender-specific probation questions, and integrates the answers into the offender's file
- Fully monitors low-risk offenders, reducing the need for face-to-face meetings
- Enables low-risk offenders to check-in 24/7 on any AB Kiosk in their jurisdiction, with less intrusive impact on their daily life
- Simplifies tracking and updating of client contact information
- Allows POs to focus their efforts on higher-risk probationers that require direct supervision



## Getting Started

A probation officer can upload his or her list of probationers into the Kiosk's Offender Management System in just a few minutes. POs can then segment their lists by assigning clients to specific check-in frequencies and customizing the monitoring/check-in process to their style of supervision:

Use the Kiosk to ask questions of probationers:

- Employment status
  - Changes to address, phone number or email address
  - Use of drugs or alcohol
  - Adherence to conditions of probation
  - Recording of UA, oral swab, and sweat patch results
- Answers to questions are automatically uploaded to the probationer's file
- Conduct randomized alcohol screenings using the Kiosk
- Use the Kiosk's Offender Management System to prepare reports by offender or by groups
- Track probation compliance at the state, local or probation officer level

The AB Kiosk is highly secure and tightly integrated with its Offender Management Software Program. Because of its autonomy, the AB Kiosk removes the busy work from the responsibilities of probation officers and provides an effective means of tracking the success of the probation programs.

## Autonomous Functions of the Kiosk

- Sends notifications to probationers to check-in at an appointed time or session
- Uses biometric fingerprint authentication to confirm the probationer's identity
- Captures video recordings of each check-in
- Delivers questions to probationers and captures their responses in the Kiosk's offender-management software program
- Issues a time-stamped receipt to the probationer
- Randomly conducts breathalyzer screenings for alcohol when required
- Allows for alcohol monitoring through a breath alcohol screening automatically conducted by the AB Kiosk should bond conditions require it
- Alerts the PO when a check-in is missed, or an alcohol screening is positive
- Updates probationers' records after each check-in

The AB Kiosk can be used as a full probation-monitoring platform for low-risk offenders. By completely automating the process for a large portion of a PO's workload, the AB Kiosk makes POs more effective, enhancing the safety of the community and reducing offender recidivism.
